BE IT REMEMBERED the Chairman and the Board of Trustees of North Sunflower Medical Center, Ruleville, Sunflower County, Mississippi, met in their Regular Meeting on Wednesday, 27 July 2022, when and where the following were present:

The meeting of the Hospice of North Sunflower Medical Center was conducted prior to the calling to order of the meeting of the Board of Trustees.

Mr. Waldrup called the meeting of the Board of Trustees to order at noon and asked H.T. Miller,III, to open the meeting with a word of prayer. The minutes of the 22 June 2022 Regular Board Meeting and 30 June 2022 were approved as distributed by motion offered by Mrs. Allen, seconded by Mr. Miller, and unanimously approved.

There was no unfinished business to bring before the Board for consideration.

The first order of New Business was to review the Initial Credentialing application of Jason Shannon, CRNA. The applicants' education and training, professional references, and License were verified, and a query was done on the National Practitioner Data Bank and the OIG. The application was carefully reviewed and after discussion, the following motion was made:

MOTION: I move to approve the initial application of Jason Shannon, CRNA and that he be given initial privileges for a period of one year ending 31 July 2023 and at that time be permitted to apply for a two-year term.

The next order of New Business was to review the Re-appointment application for one Allied Health Professional for a two year term. The application and Data Bank query of Amanda Ellis, AGNP-C was reviewed and discussed and the following motion was made:

The third order of New Business was Phil McNeer announced that Mr.Billy Marlow is personally paying for the flag in downtown Ruleville. Mr.McNeer is trying to get the U.S. flag replacement cost split between the NSMC Foundation and NSMC Hospital. The U.S. flag is replaced every three to four months. Mr. Billy Marlow stated that he is going to re-do the plaque that is currently at the base of the flag to state in memory of Robyn Marlow.

MOTION: I move to make a motion that NSMC agrees to pay for half of the U.S. flag replacement cost as needed for Ruleville, MS.

The last discussion was Joanie Perkins, Chief Compliance Officer, informed the board that she had recently attended a meeting in Washington, DC in regards to the Rural Primary Care Group. The 2 primary highlights were CMS wants all Medicare beneficiaries to be enrolled in an ACO by the end of the decade. They are strongly encouraging rural providers to start thinking differently about joining an alternate payment model or APM. Currently NSMC is in an APM with Myriad Health Alliance, a state-wide ACO that represents several CAH's and larger organizations. Secondly, Medicare is strongly encouraging partnership or collaboration with mental health providers in order to offer a fully integrated behavioral health model in rural areas.

Rodney Clark presented the financial information for June as follows. The entire facility had a cash balance of \$17.5 Million; total assets of \$49 Million, and a total liabilities and fund balance of \$49 Million. The Hospital's Gross Revenue was \$8.2 Million for the month and \$73 Million Year to Date. The Hospital had a Net Income of \$25,358 for the month and a Year to Date Net Income \$242,766. Haire Drug Center, LLC had a Net Income of \$9,648 for the month and a Year to Date Net Income of \$402,468. Hospice had a Net Income of \$19,219 for the month and a Year to Date Net Income of \$74,795. Sunflower Diagnostic Center had a Net Loss of (\$10,370) for the month and a Year to Date Net Income of \$64,846. Simply Sunflower had a Net Loss of (\$1,764) for the month and a Year to Date Net Loss of (\$7,156). Sunflower DME had a Net Income of \$48,807 for the month and a Year to Date Net Income of \$263,678. NSMC Pharmacy had a Net Income of \$22,184 for the month and a Year to Date Net Income of \$554,816. The Rural Health Clinic had a Net Income of \$134,171 for the month and a Year to

Date Net Income of \$1,218,802. NSMC as a whole showed a Net Income of \$113,082 for the month and a Year to Date Net Income of \$1,596,212.

The Administrative report was given as follows:

Daniel stated that the summer census has been decent. He said that overall it should average out good. He also stated that the new agreement with Altera will begin implementation on August 1, 2022. The plan is to have the new software completely up and running by March 2023. He announced that the business office started moving to the new location this week.

Rodney Clark presented the Quality Assurance Report as follows:

Rodney stated that in the last 7 days there have been 324 Covid test in which 18.8% positive. The positivity rate for June was 21.2%. He informed everyone that the Monkey Pox has been declared a global emergency. There has been 1 case so far diagnosed in Mississippi. There is a special kit used to test for the Monkey Pox, and we have them here at NSMC. Once the test is performed, it is sent to state and then to the CDC if positive.

Brooks Rizzo presented the Rural Health Clinic Report as follows:

She stated that the clinic saw 4,025 patients in June. The average daily walk in was 145 patients. The average daily wait time is 1 hour and 22 minutes. They are giving an average of 25 Covid vaccines per week. The clinic still has Moderna, Pfizer, and Pediatric Pfizer vaccines for ages 6 months and up are available
